

**MOTION OF METROPOLITAN EDISON COMPANY
FOR CONSOLIDATION OF COMPLAINTS**

AND NOW, Metropolitan Edison Company (“Met-Ed” or the “Company”), by and through its counsel, Lauren M. Lepkoski and Tori L. Giesler, pursuant to Section 5.81 of the Pennsylvania Public Utility Commission’s (“Commission’s”), 52 Pa. Code § 5.81, requests that the Commission consolidate the above-captioned proceedings (collectively, the “Formal Complaints”). Consolidation of the Formal Complaints is warranted and in the public interest because the Complaints involve the same Complainants and the same questions of fact and law. Consolidation of the Formal Complaints will avoid unnecessary expense and delay. In support of its Motion, the Company respectfully submits:

1. Lydia and Alan Rieger (“Complainants”) filed a formal complaint at Docket No. C-2018-3005877 on October 30, 2018. The Complaint raised issues related to refusal of installation of a smart meter at 553 Rock Hollow Road, Birdsboro, Pennsylvania 19508.

2. The Complainants filed a formal complaint at Docket No. C-2018-3005887 on October 30, 2018. The Complaint raised issues related to refusal of installation of a smart meter at 211 Ben Franklin Highway West, Birdsboro, Pennsylvania 19508.


3. The Complainants filed a formal complaint at Docket No. C-2018-3005889 on October 30, 2018. The Complaint raised issues related to refusal of installation of a smart meter at 202 Cinder Street, Birdsboro, Pennsylvania 19508.

4. Consolidation of the Formal Complaints involving the same facts and legal issues would reduce unnecessary expense and delay and promote an efficient use of the Commission's resources consistent with Section 5.81 of the Commission's regulations.¹ The Complainants may address all of the issues raised in their Formal Complaints as part of a single hearing.

WHEREFORE, Metropolitan Edison Company respectfully requests that the Commission consolidate the Formal Complaints of Lydia and Alan Rieger.


