We are counsel to Blitz Ventures LLC ("Company"), which holds an EGS license at Docket No. A-2018-2647582 to offer, render, furnish or supply electricity or electric generation services as a broker/marketer throughout the Commonwealth of Pennsylvania. Please be advised that the Company has changed its name from "Blitz Ventures LLC" to "Blitz Ventures Inc." in conjunction with the conversion from a Delaware limited liability company to a Delaware corporation. Copies of the relevant documentation filed with the Delaware Department of State and the Pennsylvania Department of State ("PaDOS") are enclosed as Attachment A.

Additionally, the Company has registered the fictious name "EnergyBot" with the PaDOS and will begin doing business under that name. A copy of the Company's approved registration is enclosed as Attachment B.

The Company maintains the same state and federal tax identification numbers (i.e., FEIN, PA Sales Tax License, PA Revenue ID) it did prior to the name change, as all state and federal taxing authorities view Blitz Ventures LLC and Blitz Ventures Inc. to be the same entity. Moreover, under Delaware law, this conversion is treated as a continuation of the original corporate entity.

Notice of the name change was not provided to customers of the Company due to concerns that it would lead to unnecessary confusion, especially considering the name change only involved switching LLC to Inc. Moreover, the EnergyBot fictitious name will be used for brokering and marketing to new customers only.

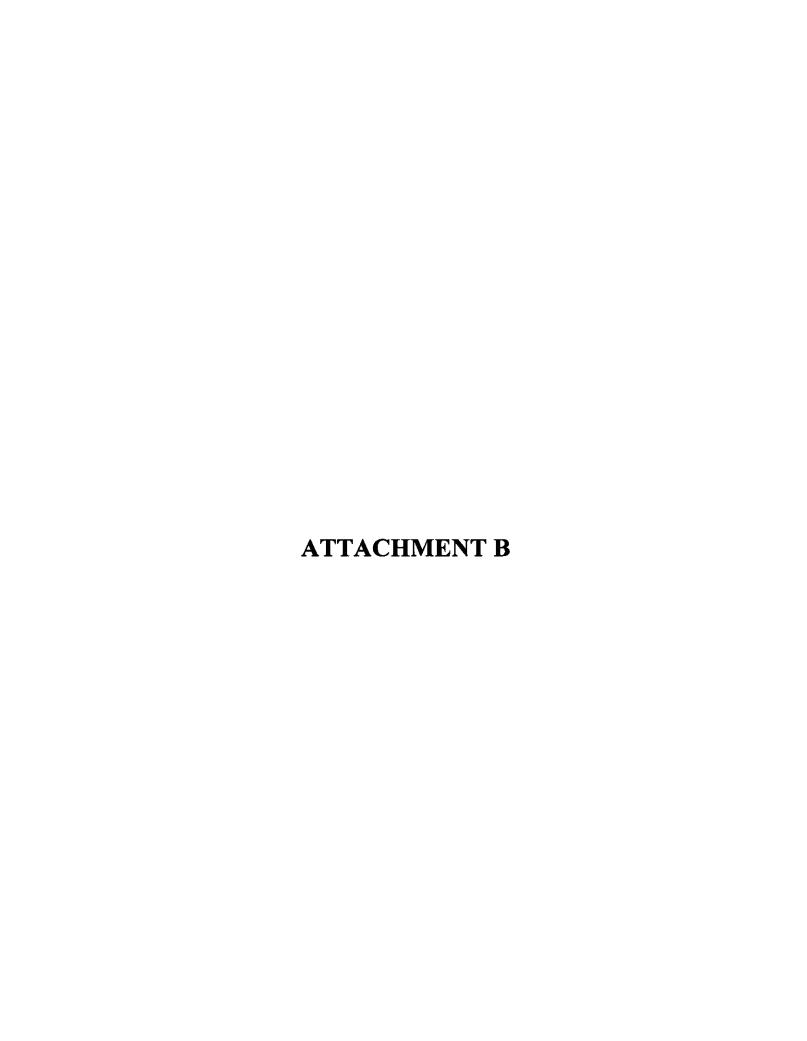
