

OPPOSITION TO MET ED MOTION TO COMPEL RESPONSES TO INTERROGATORIES AND
REQUESTS FOR PRODUCTION OF DOCUMENTS

Currently, an amended complaint is before the PUC, dated November 5. Then, on November 13, Met Ed filed a Motion to Compel. I received this motion on November 19 by mail. I request- that this motion be denied on the following grounds:

1. An Amended Complaint is before the PUC.
2. There is ample amount of time to complete the discovery process. The Interim Order dated September 21, 2018 allows for discovery to continue until February 1, 2019.
3. As stated in my Objections to the Interrogatories and Production of Documents, it is not possible to provide detailed and comprehensive answers to the questions, and provide documents to be used in this case, without knowing the precise manufacturer and model of the smart meter system, that Met Ed and First Energy seek to install at my home. Just as there are many makes and models of vehicles, my research indicates there are similarly numerous manufacturers of smart meters that have a variety of capabilities and functions.

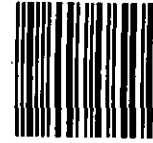
