RESTRICTIVE AMENDMENT

AND NOW, come Applicant Compassionate Provider Care Agency Limited Liability Company t/a Compassionate Provider Care Agency ("Applicant"); Protestant Rover Community Transportation, Inc. ("Rover"); and Joint Protestants Suburban Transit Network, Inc. t/a TransNet, BuxMont Transportation, Inc. f/k/a Willow Grove Yellow Cab Co., Inc., Easton Coach Company t/a Norristown Transportation Company, Tri County Transit Service, Inc., and Bucks County Transport, Inc. ("Joint Protestants") and file this restrictive amendment as follows:

1. The above-captioned application is hereby amended to clearly identify and specify the territory requested so that the authority sought shall read as follows:

To transport, as a common carrier, by motor vehicle, persons in paratransit service, from points in the Counties of Delaware and Philadelphia, to points in Pennsylvania, and return.


2. Based upon the Restrictive Amendment set forth in Paragraph 1 above, and conditioned upon its acceptance and approval by the Pennsylvania Public Utility Commission ("Commission") and any order issued being consistent therewith, Rover and Joint Protestants agree to withdraw their respective Protests to the Application as amended. Rover and Joint Protestants desire to remain a party of record so as to receive copies of any orders issued by the Commission in the proceeding.

3. The Restrictive Amendment is in the public interest because Applicant at this time is only seeking to augment its home care services in the designated geographical areas.


4. If the Restrictive Amendment is not accepted by the Commission, the parties agree that further hearings shall be held to permit Rover and Joint Protestants to present evidence in opposition to approval of the Application.

WHEREFORE, the parties, intending to be legally bound, have hereunto set their hands and seals as of this 4th day of December, 2018.




