Brian Albert Clark t/a Crystal Express ("Respondent") has paid, in full, its outstanding assessment balance for the July 1, 2016 to June 30, 2017 Fiscal Year ("2016-2017 Fiscal Year") and the civil penalty to resolve the above-docketed complaint without litigation.

On February 26, 2018, the Commission received a money order from Respondent in the amount of \$86 related to the civil penalty for Respondent's failure to timely pay the Commission's assessment for the 2016-2017 Fiscal Year. On September 4, 2018, the Commission received a payment from Respondent in the amount of \$575, which constitutes payment of Respondent's outstanding assessment balance. I&E was not properly notified of such payment.

Given that the outstanding assessment and civil penalty have been satisfied in the above-referenced matter, I&E hereby withdraws its Motion for Default Judgment filed on July 17, 2018 pursuant to 52 Pa. Code § 5.94.

In addition, I&E files this letter to certify that the above-docketed proceeding has been satisfied and should be marked closed pursuant to 52 Pa. Code § 5.24(a).
