Dear Secretary Chiavetta:

Pursuant to 52 Pa. Code § 54.34(a), please find the original and two (2) copies of this letter for filing, which provides updated information to the Pennsylvania Public Utility Commission ("Commission") regarding Dynegy Energy Services (East), LLC ("DESE"), a currently licensed Pennsylvania EGS (*See* Docket Nos. A-2010-2199236 and A-2017-2603270).

Effective January 1, 2019, DESE intends to utilize the following two fictitious names, or DBAs, in its marketing and sales operations within the Commonwealth:

- 1.) "Dynegy"; and
- 2.) "Brighten Energy"¹

¹ Vistra Energy Corp. is the ultimate parent company of licensed EGS DESE. Brighten Energy LLC, d/b/a/ Brighten ("Brighten Energy"), was a separately licensed EGS owned by Vistra Energy Corp. Brighten never served any customers in Pennsylvania, and never offered or marketed retail electric plans to customers in Pennsylvania. On October 12, 2018, Brighten Energy petitioned the Commission for authority to abandon its EGS license. (*See* Docket No. A-2018-3005308.) The Commission granted Brighten Energy's petition on December 3, 2018.



DESE's formerly-registered fictitious name, "Dynergy Energy Services", has been amended through a Pennsylvania Department of State filing to be "Dynergy". Also, DESE has added "Brighten Energy" as an additional fictitious name registered with the Pennsylvania Department of State. Attached as Exhibits A and B are the Pennsylvania Department of State letters acknowledging acceptance of the registrations of "Dynergy" and "Brighten Energy", respectively, as fictitious names of DESE.

Because DESE is not changing its legal name, and will continue to serve its existing customers under that name, DESE requests that it not be required to provide notice to its customers regarding the addition of these fictitious names.


