Re: Notice of Contract Assignment

Dear Secretary Chiavetta:

Pursuant to the Pennsylvania Public Utility Commission's ("Commission's") Order re: Interim Guidelines Regarding Notification by a Natural Gas Supplier of Operational Changes Affecting Customer Service and Contracts, entered July 20, 2000, at Docket No. M-00001343, UGI Energy Services, LLC ("UGI Energy"), a Commission-licensed Natural Gas Supplier ("NGS") in Docket No A-2013-2369286, hereby notifies the Commission as follows:

- 1. On November 30, 2018, UGI Energy and South Jersey Energy Company ("South Jersey Energy") entered into an agreement whereby South Jersey Energy assigned and UGI Energy took assignment and assumed certain contracts to provide natural gas retail supply to industrial and commercial customers in the Commonwealth of Pennsylvania. South Jersey Energy intends to reduce its participation in the Pennsylvania retail markets. The assignment of customer contracts will become effective as of January 1, 2018, or such later date as the customers whose contracts require consent to assignment provide such consent. There are approximately 35 customers in Pennsylvania whose contracts require consent to assignment.
- 2. UGI Energy, a Pennsylvania company, is currently licensed to provide natural gase supply service to residential, commercial, industrial, and governmental customers throughout the Commonwealth of Pennsylvania, including each of the natural gas distribution company service territories where South Jersey Energy's customers are located. UGI Energy currently sells natural gas, electricity and liquid fuels to approximately 17,000 commercial and industrial customers at approximately 41,000 locations in Pennsylvania, New Jersey, Delaware, New York, Ohio, Maryland, Massachusetts, Virginia, North Carolina, and the District of Columbia. UGI Energy is one of the largest marketers of natural gas in the region and has been providing reliable natural gas supplies to Pennsylvania customers since 1995.

3. All affected customers have been given written notice of the assignment, a sample of which is attached hereto as Exhibit A. This notice includes the effective date of the assignment, the complete contact information for UGI Energy as the new supplier, including a contact representative, and the reason for the assignment. Upon the effective date of each contractual assignment, UGI Energy will fully perform all contractual obligations of the supplier under the contract and will supply each customer's natural gas needs at the same prices, terms and conditions that such customer currently receives with respect to gas quantities for which such customer currently has contracted. UGI Energy will also be offering customers the opportunity to renew their contracts with UGI Energy beyond their current term of service.

Both parties are communicating this assignment to regulatory agencies and your local natural gas distribution company.

Pursuant to the provisions of your Agreement with South Jersey Energy, your Agreement may be assigned.



UGI Energy Services will administer your natural gas needs at the same prices, terms and conditions that you currently receive with respect to gas quantities for which you have currently contracted. You will continue to receive the same high quality service you have come to expect from South Jersey Energy.
