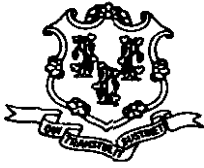

DECISION

I. INTRODUCTION

A. SUMMARY

This Decision addresses the request of Hospital Energy Services, LLC for a license to operate as an electric aggregator in Connecticut. In this Decision, the Department of Public Utility Control grants Hospital Energy Services, LLC an Electric Aggregator License to serve commercial customers in Connecticut.

B. BACKGROUND OF THE PROCEEDING

By application filed April 4, 2003 (Application) pursuant to § 16-245 of the General Statutes of Connecticut (Conn. Gen. Stat.) and §§ 16-245-1 to 16-245-6, inclusive, of the Regulations of Connecticut State Agencies (Conn. Agencies Regs.), Hospital Energy Services, LLC (HES or Company) requests the Department of Public Utility Control's (Department) approval of a license to operate as an electric aggregator within Connecticut.

C. CONDUCT OF THE PROCEEDING

By Notice of Hearing dated April 30, 2003, a public hearing was scheduled in this matter for May 12, 2003, at the Department's offices, Ten Franklin Square, New Britain, Connecticut 06051. By Notice of Rescheduled Hearing dated May 8, 2003, the hearing was rescheduled to May 21, 2003. The hearing was open and closed.

D. PARTIES TO THE PROCEEDING

The Department recognized Hospital Energy Services, LLC, 50 Bethke Road, Killingworth, CT 06419, and the Office of Consumer Counsel (OCC), Ten Franklin Square, New Britain, CT 06051, as parties to the proceeding.

II. DEPARTMENT ANALYSIS

A. COMPANY STRUCTURE

HES was formed as a limited liability company on November 15, 1996 in New Haven, Connecticut. Application, p. 1 and Exhibit A-11. The Company was formed solely to provide energy consulting services to healthcare institutions. Exhibits A-10 and A-12. HES's two managing members are Mark Mininberg and Jack Reed. Both members work part-time for HES and have no other employees. Id., Response to Interrogatory EL-1.

B. SCOPE OF SERVICE, MANAGERIAL, TECHNICAL AND FINANCIAL CAPABILITIES

The Company proposes to serve healthcare institutions such as acute care hospitals and long term care facilities throughout Connecticut. Application, Exhibit B-3.

HES intends to offer consulting services that include development of onsite generation and procurement of external electric supply. Application, Exhibit B-5. HES currently represents nine Connecticut acute care hospitals as an energy consultant. In 1997, HES negotiated a third-party supply agreement with The Connecticut Light & Power Company on behalf of Charlotte Hungerford, Danbury, Day Kimball, Manchester, Middlesex, Midstate, New Britain General, Stamford and Waterbury Hospitals for a term of five years. Application, Exhibit B-7; Response to Interrogatory CA-5. Another seven hospitals have expressed interest in working with HES. The Company will add new healthcare institutions as referred by its existing clients. Application, Exhibit B-5.

The Company receives compensation from participating customers that pay a fee of two percent on electricity procured by HES. There are no membership or other up front fees. Application, Exhibit B-5. HES does not buy or sell energy and therefore costs are limited to minimal out of pocket expenses to cover the cost of interval load data and running group meetings. Response to Interrogatory EL-4.

Based on the above, the Department finds that HES provides a satisfactory scope of service and has sufficiently demonstrated its managerial and technical capability to operate as an electrical aggregator as required under Conn. Gen. Stat. §16-245. Further, the Department finds the Company possesses adequate financial resources to provide the marketing of aggregating services.

C. CUSTOMER SERVICE

HES has provided an address and telephone number for customer service and complaints. Response to Interrogatory CA-4. HES has not been fined, sanctioned, or otherwise penalized for violation of any consumer protection law or regulation. Application, Section A-14. HES has attested that without a signed release from a customer, it would not release information to any person, including, but not limited to, information related to the quantity, time of use, type and destination of electric service, information contained in electric service bills and other data specific to the customer. Application, Affidavit No. 3.

The Department finds HES's customer service information to be satisfactory with one exception. When requested to provide a sample copy of the notice issued by aggregators to its customers under Conn. Agencies Regs. § 16-245-3(d), HES responded that it anticipated utilizing the contract executed between its aggregated customer and the electric supplier to satisfy this requirement. However, the regulation is specific in that the aggregator must provide this notice to its aggregated customer. Accordingly, the Department will order HES to provide a sample copy of the required customer information notice for review and approval. Response to Interrogatories CA-1, CA-2, CA-3, CA-5 and Application Exhibit B-6.

Based on the foregoing, the Department finds that HES's proposed customer service policies and procedures should ensure that high quality customer service is provided to its Connecticut customers.

III. FINDINGS OF FACT

1. HES was formed as a limited liability company on November 15, 1996 in New Haven, Connecticut.
2. The Company proposes to serve healthcare institutions such as acute care hospitals and long term care facilities throughout Connecticut.
3. HES currently represents nine Connecticut acute care hospitals as an energy consultant.
4. The Company receives compensation from participating customers that pay a fee of two percent on electricity procured by HES.
5. HES has not been fined, sanctioned, or otherwise penalized for violation of any consumer protection law or regulation.
6. HES did not provide a copy of the required customer service notice.

III. CONCLUSION AND ORDERS**A. CONCLUSION**

Based on the evidence presented, the Department concludes that the Company has adequate technical, financial and managerial capabilities, as required under Conn. Gen. Stat. § 16-245, to provide electric aggregating services to commercial customers in Connecticut, and that the Company's proposed electric aggregation services are in the public interest. Therefore, the Department hereby grants HES an electric aggregator license to serve commercial customers in Connecticut, subject to the following Order.

B. ORDER

1. No later than July 31, 2003 HES shall provide a sample copy of the notice to be issued to aggregated customers pursuant to Section 16-245-3(d) of the Regulations of Connecticut State Agencies.

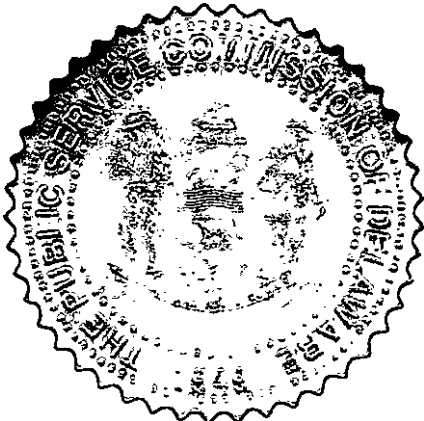

ORDER NO. 8199

ELECTRIC SUPPLIER CERTIFICATE

This 7th day of August 2012, the Commission determines and orders the following:

WHEREAS, on July 19, 2012, Hospital Energy Services, LLC ("Hospital Energy" or the "Company") filed an application seeking certification as a retail electric supplier in order to broker the sale or purchase of Electric Supply Service¹ (the "Application"). See 26 Del. C. §§1001(3), 1001(14), and 1012. Under the Electric Utilities Restructuring Act of 1999 (the "Act"),² "electric suppliers," which include Brokers, are not "public utilities," and, accordingly, the resulting sales of electric supply service to retail customers are not subject to traditional forms of rate regulation. See 26 Del. C. §§102(2) and 202(f);³ and

WHEREAS, in its Application, the Company states that it is a Broker that will utilize appropriate energy procurement strategies to

meet the needs of large commercial customers in Delaware. Staff reports that the Company's Application fulfills all of the requirements for an Electric Supplier Certificate to act as a Broker as set forth in the Commission's Rules for Certification and Regulations of Electric Suppliers, 26 Del. Admin. C. §3001 (the "ES Rules"). In particular, Staff reports that the Company appears to possess the financial, operational, managerial, and technical capabilities to operate as a Broker of electric supply service. Therefore, Staff recommends that the Commission issue to Hospital Energy an Electric Supplier Certificate that authorizes it to broker sales and customer purchases of electric supply services in the State of Delaware, consistent with the scheme adopted by the Act and the ES Rules;

**NOW, THEREFORE, IT IS HEREBY ORDERED BY THE AFFIRMATIVE
VOTE OF NOT FEWER THAN THREE COMMISSIONERS:**

1. That Hospital Energy Services, LLC (the "Company") is hereby granted, under 26 Del. C. §1012(a) and 26 Del. Admin. C. §3001, a certificate to do business and operate as an "Electric Supplier" (Broker) within the State of Delaware. Under this Electric Supplier Certificate, the Company is authorized to broker Electric Supply Service within this State in accordance with 26 Del. C. Ch. 10.

2. That the Company shall at all times provide its brokerage of Electric Supply Service in accordance with the requirements imposed by 26 Del. C. Ch. 10 and 26 Del. Admin. C. §3001 as presently adopted, or as may be hereafter amended or supplemented. The Company is hereby notified that a violation of any applicable order, statute,

regulation, rule, or other controlling authority may be enforced by the sanctions permitted by 26 Del. C. §§1012(a) and 1019 and 26 Del. Admin. C. §3001-10.2.

3. That the Company shall file, pursuant to the provisions of 26 Del. C. §1012(c)(2) and 26 Del. Admin. C. §§3001-3.9 and 3.10, such reports and pay such fees and assessments as may be required or imposed by 26 Del. C. §§114 and 115.

4. That the Company consents to the jurisdiction of the courts of the State of Delaware for all acts or omissions related to its offering of Electric Supply Services in this State.

5. That the Company is hereby placed on notice that the costs of the proceedings will be charged to it under the provisions of 26 Del. C. §114(b)(1).

6. That the Commission reserves the jurisdiction and authority to enter such further Orders in this matter as may be deemed necessary or proper.





I. INTRODUCTION

1. By this Order, the Public Service Commission of the District of Columbia (“Commission”) grants licenses to Hospital Energy, LLC d/b/a Hospital Energy Services, LLC and HES Energy, LLC (“Hospital Energy” or “Applicant”) to function as an electricity and natural gas supplier in the District of Columbia.¹ The licenses for Hospital Energy, LLC d/b/a Hospital Energy Services, LLC and HES Energy, LLC are effective upon issuance of this Order.

II. BACKGROUND

2. On April 28, 2017, Hospital Energy filed its license applications.² Specifically, Hospital Energy indicates that it intends to operate as a broker of electricity pursuant to Section 34-1505 of the “Retail Electric Competition and Consumer Protection Act of 1999” (“Act”)³ and as a broker of natural gas pursuant to the Commission’s

licensing requirements as set forth in GT 96-3, Order Nos. 12709 and 12903.⁴ In both filings, the Applicant represents that it intends to serve commercial and industrial customers in the District of Columbia. Hospital Energy provided the following information in compliance with the Commission's licensing requirements:⁵

- a) Proof of technical and managerial competence;
- b) Affidavits certifying compliance with applicable Federal and District of Columbia environmental laws and regulations;
- c) Proof of financial integrity to include financial statements;
- d) Proof that Hospital Energy has registered with the Department of Consumer and Regulatory Affairs to do business in the District of Columbia;
- e) Affidavits certifying that Hospital Energy is subject to all applicable taxes;
- f) Affidavits certifying that Hospital Energy will comply with all the requirements of all orders and regulations of the Commission; and
- g) Applicant's website address: <http://www.hospitalenergy.com>.

Hospital Energy filed supplemental information on June 9, 2017.⁶

III. DISCUSSION

3. Our review of the information contained in Hospital Energy's applications, demonstrate that it has met all the prescribed licensing requirements and that the Applicant has the ability and the financial integrity to serve electricity and natural gas customers in the District of Columbia. The Commission also finds that granting Hospital Energy's applications will serve the public interest by fostering competition in the District's energy market. Accordingly, Hospital Energy's applications are approved.

The licenses Hospital Energy, LLC d/b/a Hospital Energy Services, LLC and HES Energy, LLC are effective upon issuance of this Order.

ORDER

By the Commission:

I. PRELIMINARY MATTERS

On March 1, 2011, Hospital Energy Services, LLC ("Applicant") filed a verified application with the Illinois Commerce Commission ("Commission") requesting a certificate of service authority to operate as an agent, broker or consultant ("ABC") in Illinois pursuant to Section 16-115C of the Public Utilities Act ("Act"), 220 ILCS 5/1-101 et seq., and 83 Ill. Adm. Code 454 ("Part 454"). The Administrative Law Judge requested additional information and clarification of certain matters contained in the Application. The Applicant filed a verified response providing the requested information. Applicant requests authority to offer services as an ABC for the procurement or sale of retail electricity supply for third parties in the State of Illinois.

II. REQUIREMENTS FOR ALL APPLICANTS UNDER SECTION 16-115C OF THE ACT

Applicant is a business organized under the laws of Connecticut and licensed to transact business in Illinois. Applicant has certified that it will comply with all applicable regulations; that it will comply with informational and reporting requirements established by Commission rule; that it will comply with informational and reporting requirements pursuant to Section 16-115C of the Act; and that it will comply with all other applicable laws, regulations, terms, and conditions required to the extent they have application to the services being offered by an ABC. Applicant has agreed to ensure that any person who acts on its behalf will comply with all applicable sections of Part 454. Applicant agrees that it will remain in compliance with the provisions of the Act and Part 454, and will ensure that authorizations received from customers, and all other applicable records are retained for a period of not less than three calendar years after the calendar year in which they were created. Applicant has agreed to adopt and follow rules and procedures to preserve the confidentiality of its customers' data.

III. FINANCIAL, TECHNICAL, AND MANAGERIAL REQUIREMENTS OF SECTION 16-115C

Pursuant to the requirements of Section 454.80 of Part 454, Applicant provided a surety bond in the amount of \$5,000 issued by a qualifying surety authorized to transact business in Illinois. Applicant submitted an original surety bond in satisfaction of Section 454.80.

Applicant is required by Part 454.60 to demonstrate that it meets the managerial qualifications necessary to provide services as an ABC. Applicant must further provide an organizational chart that indicates the position of persons which satisfy the managerial qualification. Applicant has demonstrated that it meets the managerial qualifications set forth in Part 454.60, as demonstrated in Attachment A. The response to the Administrative Law Judge includes an exhibit containing a corporate organizational chart and identifying the persons who are being used to meet the requirements of Part 454.60(a). Attachment A includes an exhibit containing occupational background information on the person or persons who are being used to meet the requirements of Part 454.60(a).

Applicant is required by Part 454.70 to demonstrate that it meets the technical qualifications necessary to provide services as an ABC. Applicant has demonstrated that it meets the technical qualifications set forth in Part 454.70 with the information provided, including the information included in the response to the Administrative Law Judge. Attachment A includes an exhibit containing occupational background information on the person or persons who are being used to meet the requirements of Part 454.70(a).

The Applicant indicates in its application that it is licensed as an agent, broker or consultant in Connecticut, Massachusetts, and Pennsylvania; and that it has not had any complaints filed against it for its provision of services in the gas or electric industry.

Applicant further agrees to comply with the Code of Conduct for ABCs contained in Section 454.90.

IV. COMMISSION CONCLUSION AND CERTIFICATE OF SERVICE AUTHORITY

The Commission has reviewed the application and attachments along with the supplementary information provided by Applicant regarding the technical and managerial requirements and all other requirements of the Act and Part 454 and finds that the Applicant sufficiently demonstrates compliance with the requirements.

The Commission concludes, therefore, that Applicant's request for a certificate of service authority to operate as an ABC in Illinois should be granted and should include the following authority:

CERTIFICATE OF SERVICE AUTHORITY

IT IS CERTIFIED that Hospital Energy Services, LLC is granted service authority to operate as an agent, broker or consultant for the procurement or sale of retail electricity supply for third parties in the State of Illinois.

V. FINDINGS AND ORDERING PARAGRAPHS

The Commission, having reviewed the entire record, is of the opinion and finds that:

- (1) Hospital Energy Services, LLC, a business organized under the laws of Connecticut, seeks a certificate of service authority to operate as an agent, broker or consultant under Section 16-115C of the Act;
- (2) the Commission has jurisdiction over the party hereto and the subject matter hereof;
- (3) the recitals of fact and conclusions reached in the prefatory portion of this Order are supported by the record and are hereby adopted as findings of fact;
- (4) Applicant has demonstrated that it possesses sufficient financial, managerial and technical resources and abilities to provide services as an agent, broker or consultant for the procurement or sale of retail electricity supply to third parties in the State of Illinois;
- (5) Applicant has complied with Section 16-115C of the Act and Part 454; and
- (6) Hospital Energy Services, LLC should be granted the certificate of service authority to operate as an agent, broker or consultant as specified in this Order.

IT IS THEREFORE ORDERED by the Illinois Commerce Commission that Hospital Energy Services, LLC is hereby granted a Certificate of Service Authority authorizing it to operate as an agent, broker or consultant; said Certificate of Service Authority shall read as that set forth in Section IV of this Order.

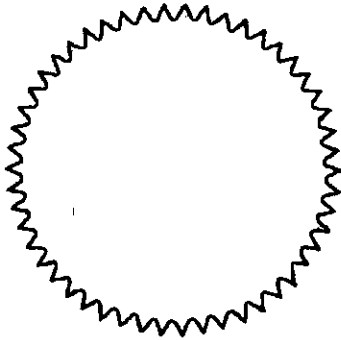

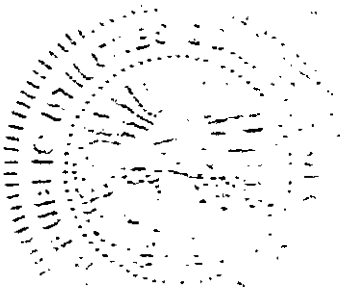


