On November 18th my existing policy on a school bus expired and I informed my insurance Agents (Edward J. Krajewski LLC) to not renew the policy on the school bus and that I would be selling the bus due to lack of work from no school district contracts.


However, I have been a funeral service livery provider for years with Tariffs on file with the PUC. The insurance and form E for my limousines was enforce at the time this letter was sent.

I need to stipulate that the insurance policies for the funeral cars and the school bus are done by different companies and have never been apart of the same policy.

In all honesty, I am completely confused by what is going on but I think the problem is with the non renewal of the school bus policy. There is no form E to file for that policy going forward.

Upon review of your records, I am certain that the appropriate Form E and required insurance is in place for the funeral cars and that the suspension is not related to my core business. I did not realize that cancelling the one policy while the other policy was still in place would have this type of result.
