On November 30, 2018, Titan Gas LLC (Titan Gas) filed a petition to reduce its bonding level from 10% to 5% of its most recent 4 quarters of revenue subject to the minimum of \$250,000, per the Commission's Order entered July 24, 2014, at Docket No. M-2013-2393141. The petition was incomplete. In order for us to complete our analysis of your petition, the Energy Industry Group requires answers to the attached question(s).
