As set forth in the above procedural schedule, claims, if any, by Company for Peach Bottom Replacement Power Cost recovery for post August 5, 1987 outage periods will not be considered or adjudicated in this proceeding unless otherwise ordered by the Commission.

The issues to be considered herein will be those set forth in the Joint Stipulation of the parties which was served under date of November 23, 1987, as well as such other issues as the Administrative Law Judge deems relevant and material.

It is to be noted that the Company requested that two separate Recommended Decisions be rendered; the first, adjudicating certain issues raised in Secretarial Letter dated June 26, 1987, and Replacement Power Cost Valuation issues; and the second, adjudicating the Peach Bottom and other outage issues.

After due consideration, the Company's request was and is denied for reasons of administrative efficiency, and to allow ample time for judicial deliberation, and because procedural time constraints would not have afforded the Commission requisite time to consider a separate first Recommended Decision before PECD's ECRF 3 filing.
