Below please find the response of ExteNet Asset Entity, LLC ("Applicant" or "EAE") to the staff e-mail inquiry on Applicant's certificated utility operations in other states dated January 8, 2019:

EAE currently holds certificates to provide telecommunications service in the following jurisdictions: the District of Columbia and New York. In the District of Columbia, EAE is authorized to provide resold and facilities-based local exchange telecommunications services pursuant to an Order granted in Formal Case No. TA 2018-04. In New York, EAE is authorized to operate as a facilities-based provider and reseller of telephone service without authority to provide local exchange service pursuant to a CPCN granted in Matter No. 18-02641.


EAE has applied for certification in the following states: Illinois (Docket No. 18-1697) and Virginia (Docket No. PUR-2018-00181).

At this time, EAE also plans to apply for certification in the following states: Alabama, Arizona, Colorado, Connecticut, Delaware, Florida, Indiana, Iowa, Kansas, Kentucky, Louisiana, Massachusetts, Maryland, Michigan, Minnesota, Missouri, New Jersey, New Mexico, Nevada, North Carolina, Ohio, Oklahoma, Rhode Island, Tennessee, Texas, Utah, Washington, and Wisconsin.
