Enclosed for filing on behalf of UGI Utilities, Inc. – Gas Division (“UGI Gas” or “the Company”) are originals of Tariff UGI Gas – PA P.U.C. Nos. 7 and 7S, seeking a general rate increase pursuant to 66 Pa.C.S. §1308. Also enclosed is an original Statement of Reasons along with the supporting data and testimony, including data required by 52 Pa. Code §§ 53.52 and 53.53. In this filing, UGI Gas is proposing to increase its annual jurisdictional revenues by approximately \$71.1 million, or by 8.9%.
