RIGHT OF WAY AGREEMENT

The undersigned Grantor, MUNICIPALITY OF PENN HILLS, for good and valuable consideration, the receipt of which is hereby acknowledged does hereby grant unto Duquesne Light Company, its successors and assigns, the right, privilege and authority to install, use, own, operate, maintain, repair, renew and finally remove one (1) anchor, (at pole# 368405-item 9) together with the guy wires and other apparatus thereto belonging, upon, over, under, along and across Grantors land, fronting on Lincoln Road, (having Tax I.D. 229-K-50) situate in the Municipality of Penn Hills, Allegheny County, Pennsylvania, and shown on Duquesne Light Company Drawing No.384006-T1 rev.2, a copy of which has been given to Grantor. Duquesne Light Company shall also have the following rights: to enter upon the land at any time for such purposes; to permit others to attach guys and related apparatus; and to sell, assign, lease or otherwise transfer any or all of the rights hereunder.

Utility shall file a copy of this Agreement with the Pennsylvania Public Utility Commission as required by Title 66, Section 507 of the Public Utility Code, and this Agreement shall become effective in accordance therewith
