To Whom It May Concern:

Pursuant to the assignment rules of the Pennsylvania Public Utility Commission, Champion Energy Services, LLC ("Champion") and North American Power and Gas ("NAPG") jointly provide notice of an assignment of residential customer contracts from Champion to NAPG. The effective date of the assignment is expected to occur as soon as practicable on or after March 1, 2019.

Champion and NAPG are affiliated entities with a common corporate parent. Based on internal business decisions, Champion has decided to assign its current residential customers to its affiliate NAPG, which is fully licensed and authorized to serve customers in all of the utilities that serve the customers that will be assigned.

After the transfer, Champion expects to have no remaining residential customers in Pennsylvania. However, Champion will continue to have and service commercial and industrial customers.

Champion and NAPG are compliant with all PaPUC assessments and AEPS obligations. Champion's and NAPG's financial security instruments are not expired and are in compliance.

Champion has included the GRT for the past four quarters for the associated customers as Exhibit 1. NAPG has included the GRT for its Pennsylvania customers for the past four quarters as Exhibit 2. Exhibit 3 provides copies of customer notices. Finally, Exhibit 4 is a certificate of service that constitutes proof that non-confidential copies of this notice have been filed with I&E, OCA, OSBA, the Department of Revenue, Office of Attorney General, and associated EDCs.


