My name is William H. Sombo, I am the owner of Strategic Law Enforcement K-9 Training Inc. In December 2017, I bought a Tow Truck. I applied for and received all my required MC, DOT and PUC numbers needed for me to operate this Towing Business. I only used the truck Monday through Friday, 0700 to 1600 hours. I had a Sub-Hauling contract with Co-Part. I was not for hire for any other companies or private citizens needing a tow truck. I had all the required Insurances needed for me to operate not only what was required for by MC, DOT and PUC, I had the required Insurance policies that Co-Part required that mirrored what MC, DOT and PUC required. I had insurance required all the way up to the day after I sold the Tow Truck on October 30, 2018.

At this time, please be advised, I do not own a tow truck any longer. I am not operating as a towing company. I have been in touch with Gerard King of the PUC and advised him at the time that I am no longer in operation. I was advised by Gerard King that he would close out my PUC file. I have sent a letter to the PUC of my termination of my Towing business. I have been out of business since the day I sold my tow truck on October 30, 2018.

On the Complaint letter, Docket No. C-2019-3006657 dated January 25, 2019, it states that Strategic Law Enforcement Canine Training Inc., (respondent) is under suspension effective December 10, 2019 for failure to maintain evidence of insurance on file with the Commission. I had been out of the business for 40 days prior to the suspension.

Please be advised that I, have email communications with Investigator Gerard King of the PUC in Harrisburg Pa. I was advised on August 28, 2018, I was in compliance and all was good with my operation. I advised Mr. King at that time that I was actively selling my tow truck and would probably not be in the business much longer. I sold my truck on October 30, 2018. I cancelled my insurance for the truck on October 31, 2018.

Please be advised; I believe this complaint is unwarranted. I no longer have a vehicle that requires a PUC number. I would request that this complaint be dismissed or withdrawn. I have followed all required requirements the entire time that I was in operation of the Towing business. I closed the business and sent a letter to PUC advising same.
