Petitions for reconsideration from actions of the staff

I, Zackery George (Complainant) am filing a petition to the decision of secretary Chiavetta to move forward with the Formal complaint without including REA Energy Cooperative. In a letter dated January 22, 2019 Rosemary Chiavetta the secretary of the Commission, stated "the Commission has no jurisdiction over rural electric cooperative in Pennsylvania"

The law states that the commission does have jurisdiction over energy cooperatives. Title 15, Article B Domestic Cooperative Corporation Ancillaries, Chapter 73 Electric Cooperative Corporations, Subchapter B. Powers, Duties and Safeguards, § 7334. Exemption from jurisdiction of Public Utility Commission.

- Except as provided in Subchapter C (relating to unincorporated area certified territory), all electric cooperative corporations subject to this chapter shall be exempt in any and all respects from the jurisdiction and control of the Pennsylvania Public Utility Commission.

The formal complaint related to Docket No. C-2018-3006495 in its entirety is related to Subchapter C Unincorporated Area Certified Territory. REA Energy Cooperative shall be required to respond to the complaint and is under the jurisdiction of the PPUC's decision in the matter.

 - o Mr. Wert also references the Pennsylvania Territorial Protection Law of Act 57 ("Act 57") and Continental Cooperative Services in his explanation of his dilemma and what entity should provide electric service. The appropriate reference appears to be the repealed Unincorporated Area Certified Territory Act of 1990, 15 Pa. C.S. §§ 7301, 7351 et seq.



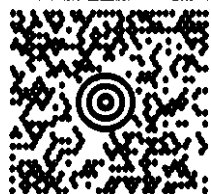

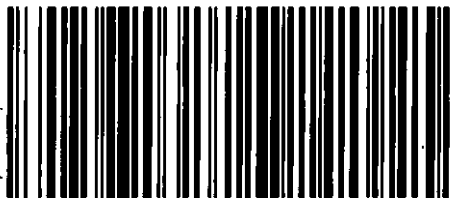
