To the secretary of the puc, Ms. Chiavetta as directed by the puc rules according to "Mr Brown" at 717-214-6214:

On February 4, 2019, the Colberts sent tracked documentation to close ALL dockets created by the puc and peco. The certified letter is to be received by today, 8 PM according to the usps tracking system and at 5:07 PM it has still not arrived.

During the course of the original formal complaint process, be it known that the puc and peco created a range of docket numbers including:

ORIGINAL 2015-2515607 Nancy and James Colbert v. peco

In 2016, puc created **2016-2561993** Nancy Colbert v. peco

In 2018 in the month of December, the docket numbers switched TWICE in puc-peco documents:

- 1) **2015**-2561993 Nancy and James Colbert v. peco **NO LONGER original 2015-2515607**
- 2) **2016**-2561993 Nancy and James Colbert v. peco **NO LONGER just Nancy Colbert v peco**

Constant switching back and forth to create an ex parte hearing. ANY AND ALL FALSELY CREATED DOCKETS HIDDEN OR TWISTED HAVE BEEN CANCELLED BY THE COLBERTS, BOTH NANCY AND JAMES.

Further be it known, that on January 31, 2019, Nancy Colbert contacted Mr Brown at the puc (717-214-6214) who advised her that dockets 2015-2515607 and 2016-2561993, which she listed, were NOT closed and the procedure for closing demanded a written letter to the secretary, Rosemary Chiavetta.

The Colberts signed a letter to state that ALL dockets are CLOSED which is referenced above, still awaiting timely delivery, although both the puc and peco have stifled and prevented past mailings under certified mailings on several occasions as the written records will demonstrate.

On February 1, one day after conversation with Mr Brown at the puc, the Colberts received an unsigned form dated January 30, 2019 stating 2016-2561993 hearing was cancelled. Furthermore, it **omitted 2015-2515607** that Mr Brown told Nancy Colbert on January 31, 2019 was still open.

On February 4, the Colberts received another puc letter with the same message, and a peco letter with the same message, BOTH omitting 2015-2515607.

AND NOW puc-peco NEED TO CANCEL BOGUS 2015-2561993 AND 2016-2561993 Nancy Colbert v peco, in addition to 2015-2515607, as well as provide written documentation to Nancy and James Colbert that ALL dockets have been cancelled by the Colberts.
