Pursuant to the Pennsylvania Public Utility Commission's ("Commission") Final Order entered on July 24, 2014 ("July 24 Order"), in Docket No. M-2013-2393141, Public Utility Commission Bonding/Security Requirements for Electric Generation Suppliers, Energy Services Providers, Inc. d/b/a Pennsylvania Gas & Electric ("Pennsylvania Gas & Electric") respectfully submitted its bonding requirements to be reduced from 10% to 5% of its most recent twelve (12) months of revenue on January 24, 2019.

On February 4, 2019, Pennsylvania Gas & Electric received a letter dated January 31, 2019 from the Commission requesting additional information regarding Pennsylvania Gas & Electric's REV-423 Specialty Tax Estimated Payments, and requests for Pennsylvania Gas & Electric to provide the calculation used to determine the prepayment of the 2018 Pennsylvania of Revenue gross receipt taxes.

Pennsylvania Gas & Electric can confirm that the prepayment amounts were based on actual revenues per each month. Please see Attachment A for the calculations used. Please note that the gross revenue amounts included the tax, and therefore, the annual return filing for the December payment was adjusted to account for this gross up.

Pennsylvania Gas & Electric respectfully requests that the Commission grant Confidential Treatment of this petition, and the attached documents. It is Pennsylvania Gas & Electric's position that the information contained in these documents is of a proprietary and/or confidential nature. Pennsylvania Gas & Electric respectfully requests that the Commission treat these documents as confidential, place them under seal, and prevent public disclosure.
