## Dear Your Honors:

On behalf of Citizens to Stop Transource, York County ("York County Citizens"), enclosed please find the Revised Surrebuttal Testimony of Dolores Krick. We are providing both a redlined version and a clean version. The only revision is the removal of a portion of a sentence on page 15, lines 14-15, which reads "is not needed for reliability in Pennsylvania or the region."

We note that this portion of Ms. Krick's Surrebuttal Testimony is what Transource Pennsylvania, LLC witness Mr. Steven R. Herling states that he is refuting by his Rejoinder Testimony on page 14, starting at line 14, through page 17, line 16 and through TPA Exhibit Nos. SRG-7RJ and SRG-8RJ. Given the revision of Ms. Krick's Surrebuttal Testimony to remove this language, York County Citizens submit that Mr. Herling's Rejoinder Testimony and associated Exhibits, which are currently the subject of a Motion to Strike filed by the Office of Consumer Advocate on February 15, 2019, go beyond the scope of Ms. Krick's Surrebuttal Testimony. This factor provides an additional reason for granting OCA's Motion to Strike, which York County Citizens supported by letter filed on February 15, 2019.

We are serving copies of both versions of the Revised Surrebuttal Testimony of Dolores Krick on all parties via electronic mail today, and we will bring the corrected clean versions to the hearing for the Court Reporter. If anyone desires to receive hard copies, please let us know and we will provide them.
