REPLY EXCEPTIONS OF PECO ENERGY COMPANY

By Secretarial Letter dated February 15, 2019, the Commission issued the Initial Decision (“I.D.”) of Administrative Law Judge Darlene Heep in this matter, which granted the Colberts’ Petition to withdraw and dismissed the complaint. Exceptions to the I.D were due within 20 days (in this case, by March 7, 2019). On February 15, 2019, PECO filed Exceptions in which it reiterated its request, initially made in a prior Motion to the ALJ, that the dismissal of the complaint should be with prejudice.

On February 22, 2019, the Colberts personally served a one-page Exception on PECO. (A copy of the Colberts’ Exception is attached.) In it, the Colberts further confirm that they are cancelling any and all dockets in their names, including all existing dockets and “any others that may come up in the future. *All are to be cancelled with prejudice.*” (emphasis added).
