Based on an instructive email received from Mr. Stephen Jakab on February 21, 2019, and pursuant to the Pennsylvania Public Utility Commission's ("Commission") Order entered on September 20, 2018 ("September 20 Order"), in Docket No. P-2017-2608078, Public Utility Commission's new process for a 5% Financial Security Reduction Renewal for Electric Generation Suppliers, Everyday Energy, LLC ("Everyday Energy"), hereby respectfully requests that its bonding level of 5% be renewed. Everyday Energy was granted its Financial Security Reduction on June 11, 2018, and its expiration/anniversary date of its current Financial Security falls on May 11, 2019.

As set forth in the September 20 Order, Everyday Energy has enclosed the following documents for filing with the Commission in support of this Compliance Filing:

1. **Attachment A**, which is a gross receipts spreadsheet for the sales to retail customers in Pennsylvania showing each month's gross receipts for the most recent four (4) quarters, including the 5% gross receipt calculations;
2. **Attachment B**, which is the Tax Status Letter of Good Standing from the Pennsylvania Department of Revenue;
3. **Attachment C**, which is the calculations used to determine Everyday Energy's gross receipt tax prepayments which were based on actual revenues for each month, along with each REV-423 Specialty Tax Estimated Payment Forms from the Pennsylvania Department of Revenue; and
4. **Attachment D**, which is an original bond and bond rider, in an amount to 5% of Everyday Energy's most recent 12-months of gross receipts.


