PECO is aware that EZ Energy Services LLC has applied for a license to provide brokering and consulting services to commercial and industrial customers on the distribution system of PECO.

In making such an application, EZ Energy Services LLC could be required to provide to PECO a bond or other acceptable financial security in an amount that PECO determines to be appropriate. EZ Energy Services LLC has indicated that it intends to provide only brokering and consulting services to commercial and industrial customers, and will not take title to any delivered natural gas; nor will accept any customer payments or deposits. Therefore, PECO has determined at this time that EZ Energy Services LLC does not need a bond or other financial security requirement, since they are not directly engaging in business with PECO and only providing brokering or consulting services to PECO customers. However, if the services provided by EZ Energy Services LLC the creditworthiness requirement for PECO's exposure to EZ Energy Services LLC changes in the future, PECO reserves the right to require EZ Energy Services LLC to provide a bond or other financial security instrument.

As you know, in making such an application, EZ Energy Services LLC must furnish acceptable security to each utility where EZ Energy Services LLC will do business. As such, under its tariff, Philadelphia Gas Works could require EZ Energy Services LLC to provide a bond or other financial security instrument in an amount that Philadelphia Gas Works determines to be appropriate.

However, you have indicated, and it is Philadelphia Gas Works' understanding, that EZ Energy Services LLC intends only to provide natural gas aggregating, brokering and consulting services at this time. You have stated that in performing these services EZ Energy Services LLC will never take title to any delivered natural gas.

Based upon your representations, Philadelphia Gas Works has determined that, at this time, EZ Energy Services LLC does not need to post a bond or other form of security to operate in its service territory. If the services provided by EZ Energy Services LLC should change, Philadelphia Gas Works reserves the right to require security from EZ Energy Services LLC as it deems appropriate.

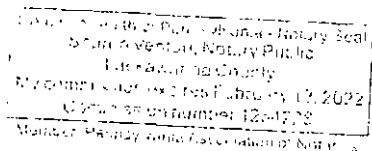

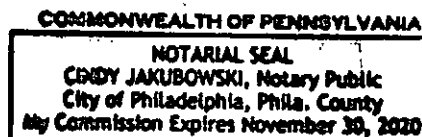
