AND NOW, National Fuel Gas Distribution Corporation ("Company") by and through its counsel, hereby files this Certificate of Satisfaction in the above-captioned action, pursuant to Section 5.24 of the Pennsylvania Public Utility Commission's regulations, 52 Pa. Code § 5.24. In support thereof, the Company states as follows:

1. On or about November 4, 2018, Lisa Tetuan ("Complainant") filed a Formal Complaint with the Commission against the Company at Docket No. F-2018-3005909.
2. On or about November 9, 2018, the Formal Complaint was served upon the Company.
3. On or about November 9, 2018, the Company filed its Answer to the Formal Complaint.
4. On March 4, 2019, an initial telephonic hearing was held before Special Agent Alphonso Arnold III.
5. The Company certifies that all parties to this dispute entered into settlement discussions and have successfully achieved a mutually satisfactory resolution of the case. The Complainant has agreed not to pursue the Complaint further.

6. Pursuant to the terms of the settlement, the Complainant has agreed to a payment arrangement where she shall pay the entirety of her LIRA in-program arrears, shall continue to make her required monthly LIRA payments, and pay off her pre-LIRA arrears by paying \$10 extra per month for forty months.

7. The Complainant has authorized the Company to file this Certificate of Satisfaction.

8. By a copy of this Certificate, the Company is providing notice to the Complainant of his right to object in writing within 10 days of the filing of this Certificate.

WHEREFORE, the parties to the above-captioned action respectfully request that this action be marked as satisfied and that the case be closed.
