I did not know I had to file a 0 income (Assessment report) the PUC sent me notices but the post office could not forward Government mail. I didn't know the mail (PUC) couldn't be forwarded, so I was fined for not filling a report. I talked to Kourtney Meyers at the PUC and thought everything was taken care of. I was fined \$499. \$199. assessment balance (don't understand why since I didn't have an income) and \$300. for civil penalty. I paid \$199. and Kourtney Meyers tried to get the civil penalty waived. I think I paid this \$199. in August 2018. This is probably not making any sense to you, but this is the only way I know how to explain what's going on. I received papers Monday March 4<sup>th</sup> 2019 stating I had not filed an answer within twenty days. I sent a letter stating that I didn't work in that yr & didn't receive anything from PUC so I shouldn't have to pay \$300. for a civil penalty, they say they have no record. I'm very frustrated that I have tried to do the right thing & pay my PUC taxes. I don't understand why the PUC mail can't be forwarded.

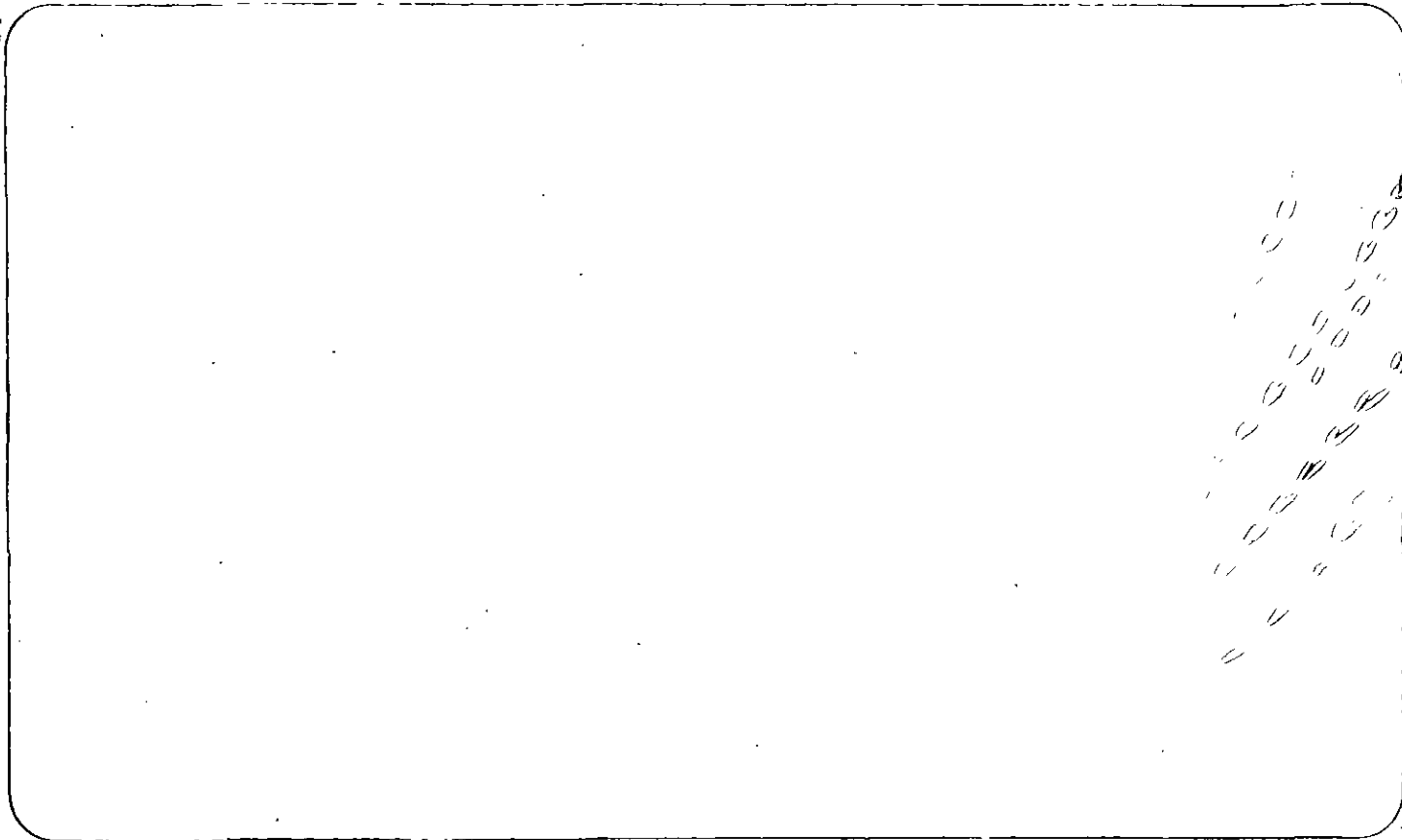
