A-1. Please identify any permits or approvals required to connect the customer in the requested territory to PAWC-WD's wastewater facilities. For any required permits or approvals, please indicate the filing status, estimated cost and the entity financially responsible for obtaining the permit or approval.

Response: The only permit which is needed for this project is a road opening permit from Highland Township. The permit will be acquired several days prior to installing the new sewer lateral. The estimated cost for the permit is \$50 - \$150 and PAWC will pay for the permit.

A-2. The Application's Section III, Paragraph 7 indicates the requested territory is 0.38 acres. However, the Application's Exhibit J notes the lot size is 0.75 acres. Additionally, the Application's Exhibit B-2 does not contain a bearing and distance description of the requested territory. Please revise the Application's Exhibit B-2 to contain a description of the requested territory by bearings and distances and reconfirm the area of the requested territory.

Response: The .38 acres that are included on Exhibit B-1 is the correct area of the requested territory. The 0.75 acres was a lot size given by the property owner on his DEP mailer. It is PAWC's understanding that that the property owner guessed the acreage of his land on his mailer. Please find attached a **Revised Exhibit B-2** with the bearing and distance descriptions of the requested territory.

REVISED EXHIBIT B-2

Pennsylvania American Water sewer franchise is located between 30 Boro Line Road and 40 Boro Line Road. Daniel Stoltzfus is the owner of the property located at 34 Boro Line Road in Highland Township, Chester County.

Mr. Stoltzfus has an existing septic system which continues to fail. Mr. Stoltzfus has an existing Pennsylvania American Water 8" sewer located in front of his property and is the most cost effective option.

To connect to this facility, Pennsylvania American Water will run a gravity 6" lateral from the existing 8" sewer main that fronts his property which is located on the north side of Boro Line Road to Mr. Stoltzfus's property.
