
Dear Secretary,

Reading Blue Mountain and Northern Railroad (RBMN) asks the Commission to reconsider the Secretarial Letter dated February 21, 2019. RBMN feels that the lack of maintenance on the Pennsylvania Department of Transportation (PennDOT) caused the premature failure of the crossing. RBMN is asking to modify the following items in the original order.

2. Reading Blue Mountain and Northern Railroad, at the sole cost of Pennsylvania Department of Transportation, shall furnish all material and do all work necessary to replace the high-type concrete surface with rubber flangeway and asphalt in order to establish a smooth and satisfactory condition.

4. Reading Blue Mountain and Northern Railroad, at the sole cost of Pennsylvania Department of Transportation, shall furnish any watch men, flagmen, inspectors, and/or engineering services that are deemed necessary in order to protect the Railroad's operations or facilities during repairs stated in paragraphs 1 and 2, herein.
