I've been calling the Pa. PUC and your office to find out my litigation court date. No one could tell me. A representative from your legal dept. said that the judge was probably the only one that could tell me, but would be too busy to talk to me. So I'm writing to you to see if you could please tell me if my litigation date is soon. I been battling Met-Ed since 2017 since I received a notice from them about my Analog Meter being removed and a Smart Meter put in its place. After negotiating on my own behalf without success I went to my State Representative's Office in Hamburg & filed a complaint with the Pa. Office of Attorney General - File # BCP-18-05-004035. From the 1st wk of Mar. 2018 thru early Nov. they <sup>tried</sup> to make an agreement with Met-Ed on my behalf with no success. They lied to the Attorney General & showed them no respect. So I went back to my State Rep. in Hamburg & filed a complaint with the PA. PUC office. Docket # C-2018-3001526. It's now been 2 yrs. since my initial contact with Met-Ed. I wrote & sent to the PA PUC all my information on Smart Meters & thru our 1st court session I was granted to continue my case, but Met-Ed should try to mediate some kind of settlement. I wrote up all my requests - showing legally why I am entitled to everything I asked for. The PA PUC tried to negotiate on my

behalf but could not come close to any agreement. So, now I must wait for a litigation date. I was told this in Oct., six months ago. I received a letter from Met-Ed that they have 3 witnesses ready to testify on their behalf & then I received a letter saying I did not return my answers to a packet of questions they wanted for court. So I sent them a letter telling them that I did fill that out completely & added about 30 pages more of handwritten answers. I also sent copies to PA PUC and Judge Watson's Office and I was sure if they <sup>(had got)</sup> misplaced them that the PA PUC would send them a copy. You see I cover myself by sending everything I write to all 3 agencies, Met-Ed, P.A. PUC and Administration Law Judges Office. This way no one can say they didn't receive something or I didn't answer something. I learned this from a lawyer I knew, he ~~is~~ now deceased. He once said to me, "You must always cover your ass!" So, now I need to know the date of my litigation in court and no one can tell me. It's 6 mos. since the interim order. And its 2 yrs. since I started this process against Met-Ed.

Now I get, Something called a Interim Order Revising Initial Litigation Schedule and Interim Order Permitting Either Party to Request a Prehearing Conference.

(I did not Request Mediation Request as a Prehearing Conference)

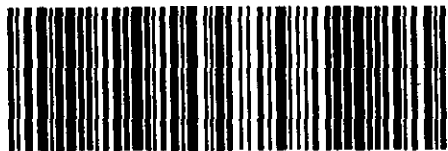

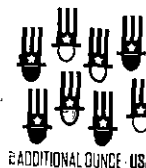
