Dear Secretary Chiavetta:

This letter is to inform the Pennsylvania Public Utility Commission ("Commission") of a Natural Gas Supplier ("NGS") name change required by 52 Pa. Code § 62.105. On July 18, 2000, ValuSource Energy Services, LLC ("ValuSource") filed a License Application to operate as a broker/marketer, aggregator and provider of natural gas supply services in the Commonwealth of Pennsylvania at Docket No. A-125092. The Commission approved ValuSource's application by Commission Order entered March 8, 2001.

ValuSource changed its name to Duquesne Light Energy, LLC ("Duquesne Light Energy") on or about June 25, 2004. By Secretarial Letter dated September 2, 2004 the Commission approved ValuSource's request to change its name for its Electric Generation Supplier License ("EGS") at Docket No. A-110142. For reasons unknown, ValuSource did not make a similar request to change its name for the NGS License.


Per staff instructions, Duquesne Light Energy provides the following information in connection with the above name change notification:

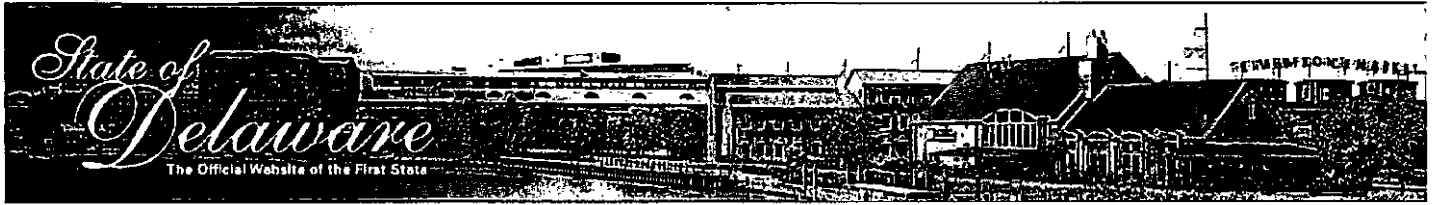




