Re: ValuSource Energy Services, LLC Name Change Filing for Natural Gas Supplier ("NGS") License Docket No. A-125092

Dear Secretary Chiavetta:

This letter is to inform the Pennsylvania Public Utility Commission ("Commission") of a Natural Gas Supplier ("NGS") name change required by 52 Pa. Code § 62.105. On July 18, 2000, ValuSource Energy Services, LLC ("ValuSource") filed a License Application to operate as a broker/marketer, aggregator and provider of natural gas supply services in the Commonwealth of Pennsylvania at Docket No. A-125092. The Commission approved ValuSource's application by Commission Order entered March 8, 2001.

ValuSource changed its name to Duquesne Light Energy, LLC ("Duquesne Light Energy") on or about June 25, 2004. By Secretarial Letter dated September 2, 2004 the Commission approved ValuSource's request to change its name for its Electric Generation Supplier License ("EGS") at Docket No. A-110142. For reasons unknown, ValuSource did not make a similar request to change its name for the NGS License.

Per staff instructions, Duquesne Light Energy provides the following information in connection with the above name change notification:

- 2. Duquesne Light Energy does not have any customers to notify of this name change.
- 3. Duquesne Light Energy has served all appropriate parties as required by 52 Pa. Code § 62.105 per the enclosed Certificate of Service.
- 4. Duquesne Light Energy has enclosed two payments in connection with this name change request: \$350 for the name change fee and \$350 for the annual NGS fee. See Attachment 1.
- 5. Duquesne Light Energy has registered its new name with the Pennsylvania Department of State, as shown in the enclosed Attachment 2.
- 6. ValuSource was formed on or about May 16, 2000 in its home state of Delaware as shown in the enclosed Attachment 3. Delaware has been notified of the name change as shown on its Secretary of State website, enclosed as Attachment 4.


