Please be advised that I represent Express Medical Transport, LLC in connection with the above referenced pending application before the PUC. I am in receipt of a letter (incorrectly) dated January 14, 2019 which states that on March 5, 2019 Express Medical Transport's application was accepted for filing and docketed. I note that on the attached page to your letter, you raise two questions as data requests. I hereby response to your inquiry as indicated below:

1. The applicant, Express Medical Transport, LLC's proposed service area is Philadelphia County, Pennsylvania, as discerned from the municipal boundaries of the City of Philadelphia. The applicant only intends to originate service from this designated area.
2. The applicant, Express Medical Transport, LLC's criteria for qualifying a client as being disabled is, "any individual who financially qualifies for assistance under applicable Medicaid criteria and who can ambulate independently or with minimum assistance. Not bed / wheelchair bound".

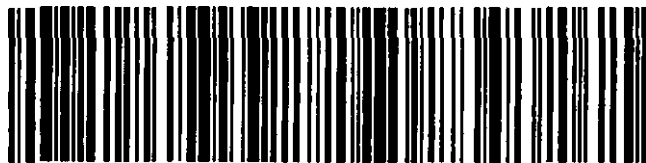
