Dear Secretary Chiavetta:

Vital Express Limo Inc. ("Respondent") has paid, in full, its outstanding assessment balance for the July 1, 2016 to June 30, 2017 Fiscal Year ("2016-2017 Fiscal Year") and the agreed-upon civil penalty to resolve the above-docketed complaint without litigation.

On December 20, 2018, the Commission received a money order from Respondent in the amount of \$7,000, which constitutes partial payment of Respondent's outstanding assessment balance of \$7,049 for the 2016-2017 Fiscal Year. On April 1, 2019, the Commission received a money order from Respondent in the amount of \$449, which constitutes payment of the remainder of Respondent's outstanding assessment balance for the 2016-2017 Fiscal Year in the amount of \$49, as well as \$400 related to the civil penalty for Respondent's failure to timely pay the Commission's assessment.

Accordingly, pursuant to 52 Pa. Code § 5.24(a), I&E files this letter to certify that the above-docketed proceeding has been satisfied and should be marked closed.


