Pasha Luxury Services, Inc. t/a The Corporate Sedan Service (“Respondent”) has paid, in full, its outstanding assessment balance for the July 1, 2016 to June 30, 2017 Fiscal Year (“2016-2017 Fiscal Year”) and the agreed-upon civil penalty to resolve the above-docketed complaint without litigation.

On April 2, 2019, the Commission received two (2) certified checks from Respondent totaling \$20,198, which constitutes payment of Respondent’s outstanding assessment balance for the 2016-2017 Fiscal Year in the amount of \$17,509, as well as \$2,689 related to the civil penalty for Respondent’s failure to timely pay the Commission’s assessment and file an assessment report demonstrating its gross intrastate revenues earned during the 2015 calendar year.


