Paul's Cab Service Inc. ("Respondent") has paid the agreed-upon civil penalty sought by the Bureau of Investigation and Enforcement ("I&E") of the Pennsylvania Public Utility Commission ("Commission") in order to resolve the above-docketed proceeding without litigation.

On March 20, 2019, the Commission received a money order from Respondent in the amount of \$250, which was the reduced civil penalty sought by I&E regarding the allegation that Respondent failed to furnish and maintain adequate, efficient, safe, and reasonable service in violation of Section 1501 of the Public Utility Code, 66 Pa.C.S. § 1501.
