**MOTION FOR PREHEARING CONFERENCE**

Respondent Duquesne Light Company (“Duquesne Light”) submits this Motion for Prehearing Conference:

1. In the Formal Complaint that Complainant Maria Santander (“Complainant”) filed on December 10, 2018, she alleged that Duquesne Light is threatening to shut off her service or has already shut off her service. Complaint, ¶¶ 4. As relief, she requested that Duquesne Light be prevented from terminating her service. Id. at ¶¶ 5. She expressly stated that her Formal Complaint is not about Duquesne Light’s smart meters. Id.
2. Duquesne Light filed its Answer and New Matter on January 2, 2019.
3. Duquesne Light has attempted to contact Complainant several times to discuss a potential resolution of this case, but has been unable to reach her.
4. Duquesne Light believes it is in the best interests of the parties and the Commission to schedule a prehearing conference to, among other things, discuss a potential resolution to this case.

WHEREFORE, Respondent Duquesne Light Company respectfully requests that the Commission issue an order scheduling a prehearing conference in this matter.
