In accordance with the Interim Order issued by Administrative Law Judge (“ALJ”) Jeffrey A. Watson on October 15, 2018 in the above-referenced matter, Metropolitan Edison Company (“Met-Ed”) offers this letter as a status report. As laid out in Met-Ed’s February 26, 2019 Motion to Dismiss, the Complainant has repeatedly failed to abide by the Interim Orders of ALJ Watson.
