



I respectfully request that the telephonic evidentiary hearing relating to the above case, scheduled for May 16th 2019 at 10am be modified for the following reasons:

- Countering new arguments from the opposing counsel would not afford complainant the opportunity to introduce additional relevant exhibits, in a timely manner and with express permission from the court.


