Dear Secretary Chiavetta:

By this letter, Duquesne Light Company (the “Company”) withdraws its proposed Supplement No. 198 to Tariff Electric – Pa. P.U.C. No. 24, filed April 1, 2019. Supplement No. 198 effectively consisted of two parts: (i) a compliance filing to lower the eligibility threshold for Rider No. 9 – Day-Ahead Hourly Price Service from 300 kW to 200 kW, as required under the Commission’s Order entered December 22, 2016, at Docket No. P-2016-2543140; and (ii) a routine update to the rates for Rider No. 8 and Rider No. 9. Consistent with subsequent guidance from Commission staff, the Company hereby withdraws Supplement No. 198, so as to file its constituent parts separately as individual tariff supplements (Supplement Nos. 199 and 200, respectively). Those Supplements will be filed contemporaneously under separate cover letters.
