 - 2) I have no ownership or management interest in any other carriers.
 - 3) I have had a driver's license for 44 years. I was a school bus driver for over 29 years. I recently retired from the Coatesville School District after having worked there as a custodian for 15 years. I have had no violations and no accidents in the past three years.
 - 4) Office in the home is equipped with a land line. Driver is equipped with a cellular telephone. My business financial records are updated and maintained manually from the home office at 19 Black Oak Drive, Lancaster PA 17602. My business hours are 6:00 am to 9:00 pm, Monday through Saturday.
- Vehicle will be parked at and dispatched from 19 Black Oak Drive, Lancaster PA 17602. Vehicle maintenance is performed by local certified mechanic. Equipment is maintained and serviced every 5000 miles. Pre-trip visual inspections are performed and vehicle is cleaned regularly.

 - c) If any new drivers are hired, I will do a road test to ensure they are a safe driver and can handle the vehicle safely.
 - d) I have a two year calendar with reminders when all driver's licenses and medical certificates expire.
 - e) Drivers will be subject to a criminal background check every two years
 - f) I have a zero tolerance policy for drug and alcohol use. All drivers, should I get a van that carries more than 15 passengers, are subject to a pre-employment drug test and enrollment in a random drug testing program.
