**MOTION FOR CONTINUANCE OF HEARING**



1. By Notice dated March 13, 2019, the Commission scheduled a Telephonic Hearing in this matter for Friday, April 26, 2019 at 10:00 a.m., before Administrative Law Judge Dennis J. Buckley.
2. Pursuant to 52 Pa. Code §5.231(a), PGW has contacted the Complainant and is attempting to reach a settlement in this matter; however, it is unlikely that a resolution will be reached prior to the scheduled hearing date.




