Dear Secretary Chiavetta:

In accordance with the Interim Order issued on October 15, 2018 in the above-referenced matter, this letter serves as a status report on behalf of West Penn Power Company ("West Penn"). In accordance with that Interim Order, West Penn initiated discovery on September 13, 2018. However, Ms. Cook has yet to respond to West Penn's discovery, despite the presiding officer issuing an order granting West Penn's motion to compel that discovery on November 8, 2018, setting a deadline of December 14, 2018 to comply. Further, the Complainant has failed to provide notification of her expert and factual witnesses in accordance with the October 15, 2018 Interim Order. To that end, West Penn filed a Motion to Dismiss this matter on February 21, 2019. That motion remains outstanding at this time.

As such, West Penn suggests that the setting of a prehearing conference in this matter would be of value to determine Ms. Cook's interest in pursuing this matter further.
