▲ **NOTE 1 - MINIMUM TRANSPORTATION CHARGES:** Sundays and Holidays: 8 hours at rates named in Columns 1 and 2. Weekdays and Saturdays (Any Hour): Based on distance from terminal to origin or destination to terminal (whichever is farthest), the following minimums will apply at rates named in Columns 1 and 3 or 4: 0 to 15 miles: 4 hours minimum; 16 to 25 miles: 5 hours minimum; 26 to 40 miles: 6 hours minimum; and 41 miles and over: 8 hours minimum.

▲ **NOTE 2 - Rates in Column 4 apply only from 5:01PM to 12:00 Midnight on any day when a higher rate is show for the following day.**

▲ **NOTE 3 - When a piano, riding lawnmower, big screen TV (50" and over), and safe is part of a move, the following charge in dollars will be assessed for each piano, riding lawnmower, big screen TV (50" and over) and safe in addition to hourly rates shown above:**

- ( 1 ) Pianos, other than players and grands; riding lawnmowers; and big screen TVs (50" and over): \$50.00
- ( 2 ) Pianos, players and grands; and safes: \$100.00

**NOTE AA** A flat charge based on one hour at the applicable transportation rates shown in Columns 2, 3 or 4 will be assessed when the distance from original point of origin to final destination is 10 miles or less.

A flat charge based on one and one-half hours at the applicable transportation rates shown in Columns 2, 3 or 4 will be assessed when the distance from original point of origin to final destination is more than 10 miles but not exceeding 20 miles.

A flat charge based on two hours at the applicable transportation rates shown in Columns 2, 3 or 4 will be assessed when the distance from original point of origin to final destination is more than 20 miles (to 40 miles inclusive).
