The purpose of this letter is to notify you that, pursuant to 52 Pa Code § 5.61(d), this matter involves a rate proceeding and Philadelphia Gas Works ("PGW") is electing not to file formal answers to the complaints filed by the Bureau of Investigation and Enforcement ("I&E") and Office of Small Business Advocate ("OSBA"), nor to any subsequently filed complaints.

On April 5, 2019, PGW filed Supplement No. 120 proposing to cancel all provisions for Liquefied Natural Gas Service ("Rate LNG") and establish the availability, rates, and terms of service for new rate for eligible customers; Negotiated Liquefied Natural Gas Service ("Rate LNG."). I&E filed a Formal Complaint regarding this filing on April 17, 2019. The OSBA filed a Formal Complaint regarding this filing on April 25, 2019.

Pursuant to 52 Pa. Code § 5.61(d), PGW has elected to not answer the complaints filed against the proposed Rate LNG-N as it views them as complaints in a rate proceeding. Please contact me if the Commission takes a different view and believes that the complaints should be answered.
