In accordance with the Interim Order issued on November 19, 2018 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). Consistent with that Interim Order, Met-Ed initiated discovery on January 25, 2019. Ms. Counts did not respond to Met-Ed's discovery. To that end, Met-Ed filed a Motion to Compel on April 18, 2019. An Interim Order was issued granting the motion and ordering Ms. Counts to provide full and complete responses by May 17, 2019. Further, Ms. Counts has failed to provide notification of her expert and factual witnesses in accordance with the November 19, 2018 Interim Order. Met-Ed timely provided notice of its expert and factual witnesses. Met-Ed suggests that it may be valuable for a prehearing conference to be set for this matter in order to determine Ms. Count's intent in moving her complaint forward.
