Dear Secretary Chiavetta:

In accordance with the Interim Order issued on November 19, 2018 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). Consistent with that Interim Order, Met-Ed initiated discovery on February 5, 2019. Mr. List did not respond to Met-Ed's discovery. Due to lack of response, Met-Ed filed a Motion to Compel on March 5, 2019. The Motion was granted by Interim Order dated March 15, 2019, which directed Mr. List to provide responses no later than April 8, 2019. Mr. List still failed to respond, and Met-Ed filed a Motion to Dismiss on April 23, 2019. That motion remains outstanding at this time.

Further, Mr. List has failed to provide notification of his expert and factual witnesses in accordance with the November 19, 2018 Interim Order. Met-Ed timely provided notice of its expert and factual witnesses. At this point, Met-Ed suggests that it may be valuable for a prehearing conference to be set for this matter in order to determine Mr. List's intent in moving his complaints forward.


