In accordance with the Interim Order issued on November 19, 2018 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). In accordance with that Interim Order, Met-Ed has completed its discovery in this proceeding. However, Ms. Martin has failed to provide notification of her expert and factual witnesses. Witness identification has been made only by Met-Ed.

At this point, Met-Ed recommends that a prehearing conference be set so as to ascertain the Complainant's intent in presenting witnesses at an evidentiary hearing in this matter, as well as to make certain revisions to the procedural schedule in anticipation of evidentiary hearings.


