
Dear Secretary Chiavetta:

In accordance with the Interim Order issued on October 18, 2019 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). As of the date of this letter, discovery exchange amongst the parties has been completed. In addition, Met-Ed identified its witnesses on January 18, 2018. Counsel for Ms. Hendin provided her witness list and written testimony of an expert witness on January 18, 2019.

At this point, Counsel for Ms. Hendin has indicated that Ms. Hendin would like to review relocation of the smart meter as an option. Met-Ed suggests that a prehearing conference be set so further discussion can occur regarding potential relocation as well as to make certain revisions to the procedural schedule in anticipation of evidentiary hearings should relocation not be pursued by Ms. Hendin.


