In accordance with the Interim Order issued on October 15, 2018 in the above-referenced matter, this letter serves as a status report on behalf of Pennsylvania Electric Company ("Penelec"). In accordance with that Interim Order, Penelec has completed its discovery in this proceeding. However, Ms. Shedlock has failed to provide notification of her expert and factual witnesses. Witness identification has been made only by Penelec.

At this point, Penelec recommends that a prehearing conference be set so as to ascertain the Complainant's intent in presenting witnesses at an evidentiary hearing in this matter, as well as to make certain revisions to the procedural schedule in anticipation of evidentiary hearings.
