Dear Secretary Chiavetta:

In accordance with the Interim Order issued on February 4, 2019 in the above-referenced matter, this letter serves as a status report on behalf of West Penn Power Company ("West Penn"). Consistent with a prior Interim Order, West Penn initiated discovery on January 22, 2019. Further, during the prehearing conference on February 4, 2019, Ms. Kansky she affirmatively agreed to extended deadlines West Penn offered. Ms. Kansky did not respond to West Penn's discovery. To that end, West Penn filed a Motion to Compel on April 23, 2019. An Interim Order was issued granting the motion and ordering Ms. Kansky to provide full and complete responses by May 20, 2019. Further, Ms. Kansky has failed to provide notification of her expert and factual witnesses in accordance with the February 4, 2019 Interim Order. West Penn timely provided notice of its expert and factual witnesses. During the prehearing conference held on February 4, 2019, Ms. Kansky indicated that she may be interested in relocating the meter at her residence and was to notify West Penn if she wished to pursue relocation. To date, no notification has been received.


