In accordance with the Interim Order issued on January 8, 2019 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). In accordance with that Interim Order, Met-Ed initiated discovery on January 29, 2019. However, Ms. DeSanto Ott has yet to respond to Met-Ed's discovery and has failed to provide notification of her expert and factual witnesses in accordance with the January 8, 2019 Interim Order. Further, the Complainant filed letters stating that she wanted to withdraw her Formal complaint. To that end, Met-Ed filed a Motion to Dismiss this matter on March 1, 2019. That motion remains outstanding at this time. Additionally, a prehearing conference has been scheduled for May 9, 2019.


